RFP for Four Laning of Munger to Mirzachauki (NH-80) section from Munger to Kharia village junction (Design Chainage Km69+520 to Km95+580) (Package 01) on Hybrid Annuity mode in the state of Bihar.

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. NH-80 including the section from km 69+520 to Km 95+580 (approx. 26.06 km). The Authority had resolved to Four Laning of Munger to Mirzachauki section of NH-80 from Munger to Kharia village junction Design Chainage Km. 69+520 to Km. 95+580 (Package-1) in the State of Bihar by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. However, Bid Security, Power of Attorney for signing the Bid, Power of attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any, shall be submitted physically in original by the lowest/selected Bidder before issue of LOA by the Authority. Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
