RFP for **Four Laning of Galgalia - Bahadurganj section of NH-327E from Km 0 + 000 to Km 49 + 000 (Package-I) on Hybrid annuity mode in the State of Bihar.**

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 327E including the section from Km 0+000 to Km 49+000 (approx. Design Length 49.000 km). The Authority had resolved to augment the existing road from Km 0+000 to Km 49+000 (approximately 49.000 km) in the State of Bihar by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.

However, Bid Security, Power of Attorney for signing the Bid, Power of attorney for lead member of Consortium, if any, Joint Bidding Agreement for Consortium, if any, Integrity Pact, and experience certificates apostile at foreign origin, if any, shall be submitted physically in original by the Lowest Bidder before issuance of the Letter of Award (LOA) by the Authority. Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
